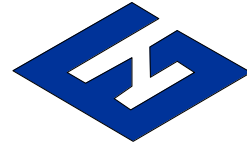
We are also planning a session-"Advances in CADD" Discussion Panel.

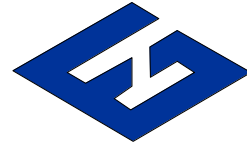

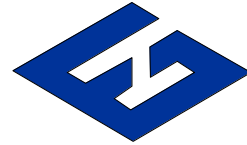
